# **Bushfire Policy**



#### **General**

Interchange Outer East (IOE) conducts a large number and range of programs, activities and one to one support for groups and individuals in a variety of locations within Victoria. In conducting these programs and activities we need to be mindful of both forecast potential and actual bushfire conditions that may make these programs and activities unsafe.

This policy is specific to bushfire situations. Please see IOE Weather Policy for guidance on other weather events.

IOE has a responsibility to ensure all people involved in our programs and activities are safe. This policy sets out the responsibilities of staff members conducting programs, activities and support work when bushfire conditions and/or events may create unsafe conditions.

Note: This policy refers to several Victorian emergency services, such as CFA and Emergency Vic. Where the emergency is an interstate emergency that may affect IOE services, please refer to the same processes, but information can be sought from the relevant interstate warning and information services listed at the end of this policy.

Triple Zero (000) is relevant Australia-wide.

# **Fire Danger ratings**

The Country Fire Authority (CFA) publishes fire danger ratings for every day within the fire danger period. These ratings are to assist the public to understand how dangerous a fire would be if it started on that day.

The CFA publishes these fire danger ratings for all areas across Victoria. The majority of IOE programs are held within the Central Fire District – however some recreational camps and holiday trips may



travel beyond this fire district. It is the responsibility of the IOE nominated 'fire watch person' to be aware of which districts activities are running in and to be aware of the fire danger ratings for that period of time.

NOTE: Fire danger ratings are updated twice daily at 5.30am and 4pm

## What do the ratings mean?

Code Red	These are the worst conditions for a bush or grass fire to occur. Homes are not deisgned or constructed to withstand fires in these conditions. The safest place to be is away from high risk bushfire areas.

IOE will base decisions and actions on the forecast fire danger rating to ensure that all people involved in our programs, activities and support are kept safe.

# **Emergency After Hours Pager**

On days where severe, extreme or code red fire danger is predicted, or bushfire warnings are in place, the after hours pager service is likely to be busy. The staff member on the IOE emergency after hours service should consult with relevant team leaders and/or general manager, and assistance will be provided where required.

The pager team may consider taking phone calls, then calling the person back from another IOE phone immediately, to keep the pager phone line free for further phone calls, which could include emergency calls from IOE staff in dangerous situations.

#### **High Risk areas**

Interchange Outer East recognises that there are some areas that IOE provides support that are of a higher bushfire risk than other areas. The risk of bushfire is most extreme in areas that are close to or among dense or open bush. IOE considers these 'high risk' areas for the purpose of this policy.

Areas within the Shire of Yarra Ranges, including IOE's Yarraburn office, are considered high risk areas. This also includes any locations around Victoria that a group may travel to, or shift locations that are considered 'close to or among dense or open bush'. If you are uncertain whether a planned destination would be considered a high risk area, please liaise with the relevant team leader or general manager.

#### **Exceptional circumstances**

Interchange Outer East recognises that there are some circumstances where the above actions may not be the safest option for IOE participants. Examples of these scenarios are as follows:

# When an IOE family is overseas/interstate and the person is being wholly supported by IOE at the time:

In planning to support a person/s for a period of time while their parents/caregivers are away, IOE staff must ask the family how a severe, extreme or code red day should be managed. The family are required to nominate emergency contacts who are capable of supporting the individual in these times if IOE is unable to. This may include an arrangement for the person to stay with, and fit into, a known support workers own emergency fire plans. This must all be discussed and agreed upon before the family leave for the planned holiday.

# **Vulnerable families and participants living independently**

IOE should identify people living in high risk areas that are more vulnerable and unlikely to have a fire safety plan in place. IOE is to refer such individuals/families into supports that can assist them to create such a plan.

IOE will contact identified people on code red and extreme fire danger days, as well as their emergency contacts to ensure they are aware of the ire danger rating, and what this means for IOE services. Emergency contacts will be made aware of any changes or gaps in support and a plan to cover an individual's support is to be implemented.

#### **Host and Specialised Care**

Host and specialised care arrangements are voluntary arrangements, and should follow the same safety guidelines within this policy for other areas of IOE.

- If the arrangement is due to occur in an area where there is risk of, or actual bushfire, the arrangement should be cancelled for safety reasons
- Host and spec care shifts should not travel to, through or into any thick bush areas, or undertake activities like going for hikes, bushwalks and similar activities when this could be a safety concern due to actual, or risk of bushfire.
- Host / spec carers and families with a host / spec care arrangement should share their fire plans with each other, so that both families have an idea of the others' fire plan.
- Host / Spec care arrangements should follow all other safety guidelines mentioned in this policy
- For further information, please speak with the family support coordinator.

# **Bushfire warnings**

The Country Fire Authority (CFA) issues warnings when a fire has started and you need to take action. These warnings are published through the Vic Emergency website

# www.emergency.vic.gov.au

You should **never** wait to receive official warning before you leave. Fires can start quickly and threaten homes and lives within minutes. This is why the above actions for forecast fire danger are in place. With the guidance of this policy, IOE services should not be in a position where they are under the below bushfire warnings.

There is a possibility, however, that this may occur during camps, as forecasted warnings may change/increase while the group is away.

There are three different levels of warnings; however they do not need to be issued in any particular order. The first warning issued could be an emergency warning.

The three warnings are:



- · An incident is occurring or has occurred in the area
- · Access information and monitor conditions.

# **MATCH AND ACT**

- · An emergency is developing nearby.
- · You need to take action now to protect yourself and others.

# **MERGENCY WARNING**

- · You are in imminent danger and need to take action now.
- · You will be impacted.

Additional messages that may be issued by the CFA include:



# ALL CLEAR

• Emergency activity in the area has subsided and is no longer a danger to you.

# **♠ COMMUNITY INFORMATION**

- o A newsletter containing updates for communities affected by an emergency.
- o Can also be used as notification that an incident has occurred but there is no threat to community.

#### Last resort – protecting yourself

Given the high likelihood of death or serious injury in such situations, it is critical that you understand the need to do everything possible to avoid having to use these last resort options.

## Sheltering in a building during a bushfire:

- Actively monitor and defend the house while inside during this time. Check for embers in the roof space and elsewhere in the house.
- Make sure you have a point of exit to the outside in every room used as a shelter. Do not shelter in the bathroom as it typically has only one door and a small window that is often frosted, minimising the view to the outside.
- Remain alert and maintain visibility with the outside to know what is happening with the fire.
- Keep hydrated. Drink water even if you don't feel thirsty.
- If the house catches fire, move through the house away from the rooms on fire, closing doors behind you.
- Plan an exit strategy for when the fire front has passed or it is no longer safe to shelter in the house.
  - Move outside to burnt ground as soon as you can.
  - If it is no longer safe to shelter in the house but still too hot outside in the open, seek another shelter option.

#### Sheltering in a car during a bushfire:

### • Position the car to minimise exposure to radiant heat:

- Park away from dense bush try to find a clearing.
- If possible, park behind a barrier such as a wall or rocky outcrop.
- The car should ideally face towards the oncoming fire front.
- Park off the roadway and turn hazard lights on. Car crashes are common in bushfires due to poor visibility

#### To increase your chances of survival

- Stay in the car, and tightly close windows and doors.
- Cover up with woollen blankets and get down below window level this is your highest priority.
- Drink water to prevent dehydration.

### As soon as you become aware that the fire front is close by:

- Shut all vents and turn the air conditioning off.
- Turn the engine off.

Be prepared: If you drive in bushfire-prone areas, keep woollen blankets in your car. This is an essential precaution during the warmer months.

# Protecting yourself from radiant heat:

- Cover up exposed skin Wear protective clothing and sturdy shoes such as boots (not sandals or runners). Cover yourself with a dry woollen blanket.
- Distance is the best protection. Move as far away as you can from the fire.
- Get behind a solid object or barrier such as a brick wall.
