


Bushfire Policy and Procedure

Interchange Outer East (IOE) conducts a large number and range of programs, activities supports and services for groups and individuals in a variety of locations within Victoria. In conducting these programs and activities we need to be mindful of both forecast potential and actual bushfire conditions that may make these programs and activities unsafe.

IOE has a responsibility to ensure all people, including staff, volunteers, and participants involved in our programs and activities are safe. This policy sets out the responsibilities of IOE when creating and conducting programs, activities, and support work during Victorian fire danger periods.

The Bureau of Meteorology (BOM) publishes fire danger ratings for every day during the fire danger period using the Australian Fire Danger Rating System (AFDRS). These ratings are to assist the public to understand how dangerous a fire would be if it started on that day.

Fire Danger Ratings



What do the ratings mean?

Catastrophic	Catastrophic - If a fire starts and takes hold, lives are likely to be lost. These are the most dangerous conditions for a fire.
Extreme	Extreme - Fires will spread quickly and be extremely dangerous. These are dangerous fire conditions. Expect hot, dry, and windy conditions.
High	High – Fires can be dangerous.
Moderate	Moderate – Most fires can be controlled.

Early planning is crucial in preparing for the fire danger period. The following information will guide participants, families and staff with what is needed to plan for the fire danger period.

Identifying High Risk Areas

IOE recognises that there are some areas that IOE provides support that are of a higher bushfire risk than other areas.

IOE will be guided by information provided by the CFA and the bushfire management overlay maps to determine the 'high risk' suburbs that will be referred to within the bushfire policy. Bordering suburbs

IOE is located and operates mostly within the central district.

There are several suburbs that border 'high risk' bushfire areas that we may need to consider as high-risk in the event of a catastrophic or extreme fire danger day. These include any areas that are close to dense or open bush, among grass or paddocks or near coastal scrub.

Identifying vulnerable participants

IOE will identify those that are vulnerable and residing in high-risk areas.

IOE will work directly with participants and their carer/family and consider the following in determining the participant as highly vulnerable:

- Living independently and solely reliant on support
- Mobility or sensory issues
- Ability to receive and understand information prior or during an outbreak.

A list of vulnerable participants residing in or near a 'high risk' area will be recorded on the fire risk management database and participant's electronic file. An emergency response plan (ERP) will be created and recorded within their support documentation.

Individual emergency response plans

IOE will work with participants at risk to develop individual emergency response plans. Emergency response plans will document how the participant wishes to be supported in the event of a <u>catastrophic</u> or extreme fire danger rating or bushfire event.

The relevant coordinator will review each ERP with the participant, carer/family annually prior to the Victoria fire danger period and check that participant records are updated to ensure appropriate action is taken when a bushfire event is triggered.

Participants travelling independently

IOE will identify all participants that travel independently to access IOE programs/services and travel to/from or through high-risk areas and record the information on the fire risk management database.

During <u>extreme</u> or <u>catastrophic</u> fire periods, IOE coordinators are required to contact these participants/families to plan other arrangements to ensure that person gets to their destination safely.

Bushfire planning with families

IOE believes that participant, carers/families, and staff have a shared responsibility to plan and respond in an emergency. IOE will work in partnership with participants and carers/families in developing emergency response plans.

IOE will work with families residing in high-risk areas to encourage them and link them in with services to assist with preparing a bushfire plan.

Participants and families should consider, as part of their bushfire plan, how they will manage without IOE supports during a <u>catastrophic</u> event or a bushfire outbreak, and their ability to make alternate arrangements or relocate during periods determined as catastrophic or extreme, as these ratings may apply for a number of continuous days.

Staff enacting their own fire plan

IOE understands that staff living in high fire areas may need to enact their own fire plans for their family on these days, making them unavailable for their scheduled employment.

Staff that provide direct support that are intending to enact their family fire plan and not attending scheduled work commitments must contact an IOE coordinator or line manager during business hours or the emergency after hours phone to advise.

During periods of <u>extreme</u> and <u>catastrophic</u> fire rating days and during bushfire outbreaks, there are likely to be less staff available as they are enacting their bushfire plans.

Staff living in high fire areas - working from home arrangements

Staff that live in high fire areas that have existing working from home arrangements are expected to have a bushfire plan in place. During periods of <u>extreme</u> and <u>catastrophic</u> fire danger periods, IOE strongly encourages staff to leave areas that are 'high risk' and work in an alternative workspace. IOE can provide office spaces in one of our existing offices.

If staff wish to take time off to enact their individual bushfire plan, they can access time in lieu or other accrued leave. Staff should liaise directly with their manager.

Communication

IOE will work with participants, carers/families, and staff to communicate our bushfire preparation and response in the following ways:

- Direct written correspondence
- Social media
- Newsletters
- Direct phone communication, including SMS

Exceptional circumstances

IOE recognises that there are some circumstances that directions included within this policy are not the safest option for participants or staff. Alternative directions may be provided by the CEO, general manager, or their delegate. Any decisions that differ from directions within this policy will be guided by undertaking a thorough risk assessment.

Monitoring of bushfire ratings and bushfire outbreaks

IOE will monitor bushfire ratings via the Vic Emergency website for the central area and any other area where camps or activities are located.

IOE will communicate to staff and participants/carers when bushfire ratings are <u>catastrophic</u> or extreme via social media, email, and direct messages.

All IOE staff are required to download the Vic Emergency app and check the ratings prior to entering a high-risk area. Staff should then monitor local conditions for outbreaks and notify IOE immediately if an outbreak occurs.

Participants and carers/families that reside in a high fire danger area should monitor conditions during the bush fire season. DO NOT rely on IOE to provide notice of fire danger ratings or bushfire outbreaks. Families should not wait for information from IOE before enacting their own bushfire plan.

IOE sites in high-risk areas

The IOE office sites located in high-risk areas will have a bushfire action plan that will state the actions to be taken during the Victoria fire danger period. This bushfire action plan will identify safe actions for staff and visitors to those sites to take prior to and during a bushfire event. IOE sites located in high-risk areas will close on extreme and catastrophic fire rating days or where there is a bushfire outbreak that may threaten the safety of staff and participants.

Recreation and other group-based activities and camps

During the fire season, IOE will conduct a risk assessment prior to selecting the location of a camp or activity and avoid 'high risk' areas to minimise the need to cancel or relocate the activity.

Each camp or activity will have a relocation plan in place prior to the activity in case of a catastrophic or extreme fire rating or a bushfire outbreak. This will include information about the bushfire district, risk assessment and camp site evacuation plans.

If the risk is too great for a planned activity or camp to go ahead an alternative activity or location may be offered. Recreation activities heading to high-risk areas may be cancelled if IOE is unable to support the activity safely with staff and volunteers, or a safe alternative activity or location is not available.
